As we ease restrictions on surgical services to avoid unintended patient consequences of pandemic surgical delay, it is important that we continue to remain vigilant. Please know that CAS will continue to advocate for protection of healthcare workers and the ethical use of PPE and preoperative COVID-19 assessment using public health and infection prevention and control pandemic recommendations. As a reminder, the [CAS website](#) remains a valuable source for your education, with links to these webinar and online resources. Please be sure to utilize them.

By way of introduction, I grew up in St. John's, NL and completed my anesthesia residency in 1997 at Memorial University. I moved with my husband, Roger, and then young family to Nova Scotia in 1999 to complete an Obstetric Anesthesia Fellowship at the IWK Health Centre and an MSc in Clinical Epidemiology. It is 21 years later, and my husband and I now have three adult children attending university, and I lead an academic practice as Professor and Chief of the IWK Women's & Obstetric Department of Anesthesia in Halifax. Yet I locum in rural Nova Scotia community hospitals and thus I bring a broad depth of understanding of the practice of Canadian anesthesiologists.

My involvement with the CAS began in my final year of training when I joined as a resident member in 1997. I have a long track record of serving and representing

the Society on local and national committees and advocating for both patients and our profession. As professionals, anesthesiologists can impact change for patients and serve society through our excellent clinical care, research, education, and administration. Taking this further, anesthesiologists are well positioned within healthcare to influence system-level changes not only within our institutions, but also at both provincial and national levels. This allows us to advocate for patients and colleagues, and impact healthcare improvements in the ever-changing landscape of medicine.

As I look ahead, there are many significant areas that need our focus. While I plan to serve our community across all areas, it seems primary subjects needing our advocacy will be diversity and inclusion, physician wellness, and human resources. We created a Diversity, Equity and Inclusion (DE&I) working group in 2019. With the initial work of the group completed (assess organizational inclusiveness, ensure that any systemic biases or barriers are addressed and removed, develop and implement a diversity and inclusion statement), we transitioned the working group into an active CAS Committee, whose mandate will be to continue this work and ensure diversity and inclusion becomes embedded in all aspects of our daily work and in the fabric of the Society.

This focus meshes well into the area of physician wellness, which has become an area of emphasis and will continue to be so in the coming months and years as we strive to improve the health and wellness of Canadian anesthesiologists.

Finally, a key priority area for me will be health human resources. We have seen there are workforce issues with shortages in anesthesiologists across the country. I encourage you to engage in our profession and the Society, as we all have a stake and responsibility for the success and future of anesthesia as a specialty. We need open conversation and to help lead the dialogue. CAS has to become a strong advocate for solutions and provide input to stakeholders that will address this, both at national and local levels that support the profession and the provision of safe, timely, and equitable anesthesia care.

As I close, I would like to express the gratitude of the Executive Committee to Debra Thomson, CAS Executive Director, and the national office staff team for their outstanding commitment, leadership and management of the Society for our members. This small team of professionals work tirelessly behind the scenes to provide outstanding programs, services and benefits, and lead and manage all volunteer partnerships that make our Society run effectively and efficiently. Their focus on fiscal financial health has positively positioned CAS for the years ahead. Please take time to appreciate their work on your behalf.

As President, I hope to hear from you, our members, and represent all your voices from across Canada. I am very proud of our profession and all that you do. I look forward to serving you as CAS President. I can be reached at president@cas.ca.

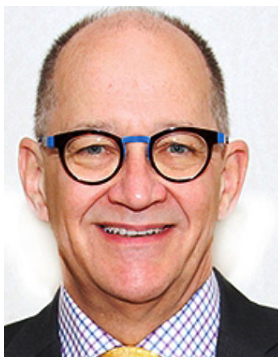

REPORT ON RESIDENT ENGAGEMENT, ADVOCACY AND PROFESSIONAL CITIZENSHIP IN CANADA

Dr Rohan Kothari and **Dr Janny Ke** recently published a report in the *Canadian Journal of Anesthesia (CJA)* on resident engagement, advocacy, and professional citizenship in Canada. Both Drs Kothari and Ke have been active members of CAS for several years. Dr Kothari served as the Resident representative on the Board from 2017-2019, and Dr Ke was the Residents' Section Chair from 2017-2018.

The article titled "Professional Advocacy and Citizenship: A Continuing Journey that Begins during Residency" explores the development of professionalism and advocacy in anesthesiology, with a focus on the role of residents. By combining research, case studies, and the results of national resident needs assessment surveys, the report identifies the important role early support plays in the development of anesthesiologists.

Feedback from Canadian residents clearly identifies key communication, career, and educational resources, financial supports, and social engagement targeting areas for ongoing improvement of resident engagement.

The report further examines the impact of professionalism and how it goes beyond clinical care, research, and education, and includes involvement in leadership and healthcare policy.

The report concludes that professional citizenship is crucial to the future of anesthesiology in Canada and must be nurtured starting in residency.

DON'T MISS OUT - EXCITING AND ENGAGING POSITIONS:

Vice Chair (2 positions available):

Roles include creation of resident engagement initiatives, liaison between university representatives and CAS, organizing resident speaker sessions for the CAS Annual Meeting, and coordinating the SIM Olympics. Applicants entering this role will be transitioned to becoming the CAS Residents' Section Co-Chairs for the 2021-2022 year.

Communications Officer:

Roles include implementing resident outreach initiatives, maintaining the CAS Residents' presence on social media (Twitter and Facebook), organizing the Fellowship and Career Fair at the CAS Annual Meeting, and engaging university representatives in local events.

Finance Officer:

Continuing Education and Professional Development Committee (CEPD):

The CEPD Committee is responsible for advising the Board on all matters regarding Maintenance of Certification and the continuing professional development of members in anesthesia and related fields.

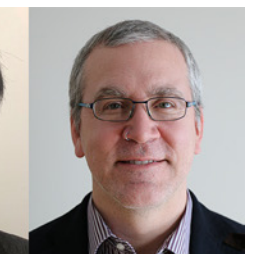

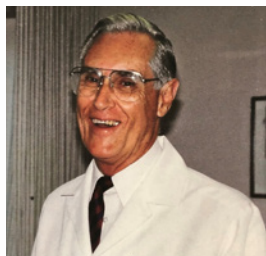

IN MEMORIAM: DR GRAHAM H MCMORLAND (1926-2020)



Dr Graham Hugh McMorland passed away in his sleep on August 1, 2020 at his home in South Africa with his wife, Elizabeth (Beth), by his side. A long-time member of the Canadian Anesthesiologists' Society (CAS) and the Society for Obstetric Anesthesia and

Perinatology (SOAP), he was well-known for his interest (and love) of obstetric anesthesia.

Graham was born in Pretoria, South Africa. Towards the end of World War II, he served two years in the Royal Navy before attending medical school at the University of Cape Town. Following graduation in 1951, he and Beth did medical mission work in Nyasaland (now Malawi) where he became assistant Medical Director of Malamulo Mission Hospital and then Medical Superintendent. In 1956, he entered residency training in anesthesiology at King Edward VIII Hospital in Durban, obtaining his Diploma in Anaesthesia from the Royal College of Physicians and Surgeons of England in 1959. He then practised in Northern Rhodesia (Zambia).

In 1963, Graham and his family immigrated to Hamilton, Ontario, where he practised for several years. In 1970, he crossed the country to join the Department of Anesthesia at Vancouver General Hospital. There he pursued his interest in obstetric anesthesia, eventually taking on the mantle of Head of the University of British Columbia's (UBC) Division of Obstetric Anesthesia. When the new women's hospital (an amalgamation of the obstetric departments of Grace Hospital and Vancouver General Hospital) opened in 1982 he became Head of the Department of Anesthesia. The new hospital was known first as Grace Hospital and later as BC Women's Hospital, the largest obstetric hospital in Canada. He was a respected leader in the hospital and attained the rank of Clinical Professor at UBC. Retiring from practice in 1991, he was honoured by UBC with an appointment as Professor Emeritus. In 1997, Graham and Beth moved to Mexico, returning to Vancouver in 2000. They ultimately found the winters too cold and in 2011 returned to South Africa. His later years were complicated by myelodysplastic syndrome.

While Head of the Department at BC Women's Hospital, Graham fostered obstetric anesthesia research and was responsible for establishing the fellowship program which continues to this day. The early fellows included Drs John Fuller and Chantal Crochetiere, both now well-

known in CAS and SOAP circles. Graham mentored students, fellows and staff, many who became stalwarts in the CAS and SOAP. His research publications included the effect of pH adjustment of local anesthetics, post-caesarean delivery analgesia (epidural morphine, PCA for post-general anesthesia cesarean analgesia) and spinal anesthesia. He encouraged the first studies in patient-controlled epidural analgesia (PCEA) for obstetric analgesia and collaborated with the UBC Department of Pharmacology on studies of metoclopramide.

Graham received many honours: the B.C. Anaesthetists' Society Service Award, the Gold Medal of the Canadian Anesthesiologist' Society (CAS) – its highest honour – and was President of SOAP in 1983-84. He was active in the Obstetrics Section of the CAS and co-authored its statement on bupivacaine toxicity with respect to obstetrics. As an active member of the World Federation of Societies of Anesthesiologists (WFSA), he co-edited the Handbook of Obstetric Anesthesia with Dr Gertie Marx in 1992. Known for his dry wit and excellent speaking skills, he was a sought-after speaker/teacher throughout the world.

Graham was active in a smoking cessation program (5-Day Stop Smoking Plan) and while in Vancouver, he hosted a phone-in radio program answering medical questions (always referring people back to their own physician). He had many interests outside of medicine such as sailing, reading, and learning new languages (proficient in some, in others he was able to make himself understood). He was a lifelong learner, well before that became a buzzword, and was deeply religious. In his early medical career, he and Beth served on medical missions. They continued that following his retirement and provided medical services in refugee camps in Rwanda.

Graham will be remembered as a superb clinician, mentor, teacher, researcher, and leader. He was an inspiration to all who were privileged to work with him. He loved meeting new people and helping people reach their full potential. He laughed easily and often. He was always a gentleman. He treated both men and women with respect. Dr Graham McMorland will be sorely missed.

Graham is survived by his wife Beth, daughters Elizabeth and Patricia, five grandchildren and 10 great-grandchildren. They were his joy and delight.

IN MEMORIAM: DR. JOHN JEREMY LEWIS CROSBY (1936-2020)



Dr. John Crosby was born in Nuneaton, England and attended medical School at St Thomas' Hospital in London and graduating in 1961. Following House Surgeon positions in London and Leister, and a period of time as an anatomy

lecturer, John came to Canada where he spent some happy years as a full-service family physician on the Sunshine Coast in Gibsons. He did additional training in anesthesia at the Vancouver General Hospital and achieved his Royal College Fellowship in Anesthesia in 1974.

John worked at St. Paul's Hospital until 1977, moving to a position at the Royal Columbian Hospital (RCH) in New Westminster. He had a long and fruitful career at the RCH as a general anesthesiologist and with an interest in chronic pain midway through his career, and which led him to co-found the Diagnostic and Therapeutic Nerve Block Clinic in the Royal Columbian and Eagle Ridge hospitals.

During the course of John's career, he held the title of Clinical Associate Professor of Medicine in Anesthesia at the University of British Columbia (UBC), and he served the community as Head of the Department of

Anesthesia at Royal Columbian Hospital from 1984-86, on the Executive of the B.C. Anaesthetist's Society from 1982-87 including as Chairman from 1984-86, as a Member of Council of the Canadian Anaesthetist's Society from 1983-86, and as a member of the Standards Committee from 1985-87. He retired from anesthesia practice in 1997 but continued treating patients with chronic pain until 2002. He was consistently described by his patients and colleagues as a gentleman, dedicated physician, and a great mentor.

John was also very musically talented, writing and performing music often in the form of skits. He was a dedicated member of the Vancouver Welshman's Choir for 28 years, serving on the music committee as well as arranging music that the choir still sings to this day. When not in song or 'passing gas,' John could be found in his garden getting incredible satisfaction from each flower and plant while raging against each weed and slug. He loved spending time with friends and family, whether it was on the tennis court, golf course, gathered around a piano, in raucous debate or sharing a naughty joke, always with a twinkle in his bright blue eyes.

He is survived by his wife, Marijke, his two daughters, Mariette White (Ed) and Michelle Crosby (Joel Bridle), and four grandchildren.
